# TO THE DEFUNCT LODGE TRUSTEES OF COTTONWOOD (MURRAY), UTAH LODGE NO. 2344

Pursuant to the authority of Article IV, Section 12 of the Constitution of the Benevolent and Protective Order of Elks, Section 9.170(c) of the Laws of the Order, with the Board of Grand Trustees approval and the recommendation and concurrence of the State Sponsor Louis J. Grillo, Past Grand Exalted Ruler, I do order, instruct and authorize the Trustees of the defunct Cottonwood (Murray), Utah Lodge No. 2344 to **execute**, **transfer** and **deliver** the total assets held by them, in the amount of \$1,126,159.00 plus any accrued interest since the last reporting period, to the following tax-exempt 501(c)(3) entities within the Utah Elks Association, complying with the meaning of Section 501(c)(3) of the Internal Revenue Code as required by Section 9.170(c) of the Laws of the Order. The distribution of said assets shall be as follows:

50%, plus any accrued interest, to the Utah Elks State Major Project, Camp Wapiti

50%, plus any accrued interest, to the Utah Benevolent Elks Trust (UBET). These funds are to be invested into a restricted account, and the interest earned on the account used for improvements in the State or wherever deemed necessary. Spending of the principal is only at the direction and approval of the State Sponsor.





June 2013 Dave and I were given the job to be Trustees of the Defunct Lodge Cottonwood/Murray Lodge 2344- in 6 months we had sold all the Assets and by January 31, 2014- we invested the total amount of 750,000.00- over the past 5+ years our investments have been good to the Trust.

At Spring (2019) meeting we request that the total funds be returned to Utah and Grand Lodge granted it this past June.

It was to be divide 50/50 to the State Major Project and UBET- with strict guidelines- UBET's 50% will be in a restricted account (meaning the principal monies cannot be used- without STATE SPONSORS approval) and the earnings/interest must be used for Charity.

If I could please have a representative from Camp Wapiti and UBET come up.

The total amount in the investment trusted on the day we transferred was 1,280,591.99

Leaving in UBET restricted investment account of 640,296.00

Transferred to the Camp Wapiti investment account was 640,925.99

Safe travels and we'll see you in Cedar City!



## Message from our State Sponsor, Hon Jim Grillo, PGER


To the Members and Officers of Utah Elks Association,




