He founded his company, Appraisals Plus, in 1992 after becoming a Certified Real Estate Appraiser,

Randy was proposed and initiated into Lawrenceburg Lodge No. 2206 in 1993 and continues to this day to be an active and dedicated member, He served as Tennessee State President in 2005- 2006. Randy was named Area 3 Grand Lodge Government Relations Member from 2007 through 2009. He was elected Grand Treasurer for 2009-2010. Randy was named Area 3 Public Relations and Marketing Member from 2014 to 2018. In 2018, he was elected to represent Area 3 on the Board of Grand Trustees, serving as Building Applications–West Member in 2018-2019, as Pensions and Benefits Member in 2019-2020, as Secretary of the Board in 2020-2021 and Chairman of the Board in 2021-2022.

Randy and Wanda were married on March 19, 1982, and together they have two sons: Brad and Billy. Tragically, Brad died in 2021 after a brave fight against pancreatic cancer. Randy and Wanda continue to reside in Lawrence County, Tennessee where they are surrounded by extended family, friends, and most importantly, their four wonderful grandchildren: Madison, Jacob, Griffin, and Vaida.

#### **U.E.A. Constitution and By-Law**

Every five years our By-laws need to be updated and ratified by U.E.A membership, Lodges and submitted to Grand Lodge.

Our last update was completed in 2020. In this current process it was requested that three additional items in U.E.A Constitution and By-Law be changed.

To accomplish this a rough draft will be submitted to U.E.A membership at Spring Meeting in March in St George for discussion and input. If supported by the membership, a final draft will be submitted at the State Convention in May in Provo. The next step would be to read and post proposed changes to the membership in preparation for voting at the Fall Meeting.

Item 1. Proposed change: for U.E.A going to two State meetings a year, instead of three.

- Item 2. Proposed change: for the eliminating the office of President Elect.
- Item 3. Proposed change: Past State President / Past District Deputies Association to Past State President Association. Item 4. Correct any spelling, punctuation, and formatting issues in the final document.

For some of these items, the members at the Spring Meeting will be asked for a consensus on the changes. For example: if the U.E.A support the two meetings a year, what meeting will be utilized March or May and what will this meeting be called (Spring Meeting or Convention). Several names are used in the document, need some clarification.

I know this does not answer all your questions, but hopefully during the Spring Meeting we will be able to do that.

#### STATE VETERANS COMMITTEE

This quarter has been very busy throughout the State with winter and the Holidays.

At the Ogden Home the Veterans celebrated their Birthdays and were visited each month.

The Committee that volunteers at the Payson Home helped with a Halloween Party for over 800 kids plus parents and everyone had a great time. In December the Committee purchased stockings for all the Veterans at the Home and filled them with candy and flashlights. They also contacted a local credit union who supplied each Veteran with a calendar. These treats were delivered on Christmas Eve.

The Committee who works at the Salt Lake City VAMA coordinated with the Homeless Veterans Department to purchase needed items for the winter. They purchased 21 pairs of boots, 14 pairs of gloves and 21 pairs of winter socks. They were also able to distribute 50 winter jackets that had been donated.

Volunteers from St George Lodge 1743 donated many hours to helping with programs at the Southern Utah Veterans Home in Ivins. They supply help to Bingo 2 days a week, a Birthday Cake and visit each month, assisted Veterans with shopping at Walmart, assisted the Veterans at restaurants for breakfast or lunch and travel in the vans for fun excursions to help with wheelchairs and walker dependent veterans. Additionally, we provided many volunteers to assist at the Halloween party with over 800 kids and parents. This is an annual event that the community looks forward to and we were able to provide 8 volunteers, in costume, to help the Veterans and Trick or Treaters. Christmas was a busy time in Southern Utah as we held our Christmas Tree event again this year. 173 Veterans names were on the tree this year. The Stars with gift wishes were taken by Lodge members very quickly and Veterans at 8 different homes and care facilities received much that they asked for. The Ivins Home allowed the Veterans Committee to deliver the gifts to each of the 100 Veterans at 8:30 a.m. on Christmas morning. What a great way to start this special day with a gift, a Merry Christmas wish, and a big smile. We were met with a sincere Thank you!

## **DRUG AWARENESS**

This year I am proud to announce that we had two nominees submitted for the Enquire "Kiki" Camarena award. For those that may not know, this award is given to a Drug enforcement officer who has gone over and above in helping to stop the drug traffickers. One of the nominees came from the Cedar Lodge and the other from St. George, thanks to Tiffany Hansen and Mary Ann Novak Lodge Chairs. The State winner was from the Washington County Drug Task Force (WCDT), Detective Brett Gibson and was sent on to DAP Directors for judging at the National level. Results will be released in March. Below is an excerpt from the nomination letter.

"As a narcotics detective, Detective Gibson has excelled in every aspect of his responsibilities. Over the course of five years, Detective Gibson conducted over 267 drug related investigations. As a result of these investigations, multiple individuals were identified and arrested as persons involved in the distribution of illegal drugs in Washington County, Utah. One of his investigations identified a transnational Drug Trafficking Organization (DTO) operating in our area. This DTO was responsible for the sales of methamphetamine and fentanyl pills in ourCommunity. This investigation resulted in the federal indictment of multiple individuals in Utah, California, and Mexico. Over one hundred pounds of methamphetamine and thousands of fentanyl pills were seized in this investigation that would have ended up in our community."

The nomination along with a copy of an award that the WCDT under the direction of Detective Gibson's had been given "2021 Outstanding Task Force of the Year for your exemplary hard work and success investigating significant drug trafficking organization impacting the communities of the Rocky Mountain Region".

The Rocky Mountain High Intensity Drug Trafficking (HIDTA), who was awarded WCDT, encompasses thirty-four designated counties in Colorado, Montana, Utah, and Wyoming. They have all been working together to reduce what is coming through the I-15 corridors. So please be aware that it is in your communities as well and the lodges need to continue to get this message out to our children/parents, and lodge chairs need your support just like any other committee.

Remember DAP can be incorporated with other events involving children and informational pamphlets should be displayed for parents and grandparents in your Lodge.

Currently, we have so much information at our fingertips. Shopping at our fingertips, asking Google or Alexa or Seri for an answer and having it immediately. We carry a computer in our pockets that is more powerful than the guidance computer NASA used for the famous Apollo 11 mission. Ever faster, technology advances at warp speed and computing power grows exponentially.

It is good practice to stay away from suspicious attachments or links. In many cases it is possible to see the source of a link by right-clicking or long-tapping it. If you have any doubt as to the link's origin, this technique may reveal its source. With attachments, carefully examine the email's contents, subject line, and file extension before opening. If there are strange typos or odd extensions on the attached file, it is best to steer clear.

Here are 10 top tips to stay safe online:

- 1. Keep a clean machine.
- 2. Create long, unique passwords.
- 3. Use password manager.
- 4. Enable multi factor authentication.
- 5. Think before you click.

- 6. Report phishing.
- 7. Use secure Wi-Fi.
- 8. Back it up.
- 9. Check your settings.
- 10. Share with care.

# LITTLE WARRIORS CAMP

Ten years ago, Robert and Adele Pagnani, along with three veteran friends, created the "Little Warriors Camp" for kids who have lost a parent killed in action or have committed suicide related to PTSD. There are currently 117 "Little Warriors" in Utah.

Little Warriors Camp is held at Camp Wapiti, a 50-acre mountain retreat operated by the Utah Elks, located up Settlement Canyon above the town of Tooele, Utah every July. The facilities include a dining hall, seventeen cabins which can sleep up to twelve people each, a swimming pool, zip line, basketball court, pavilion, outdoor theater, arts, and crafts building and many other amenities.

This year's Little Warriors Camp is July 19-21 This special weekend consists of an outdoor experience for the children, surviving spouses, and parents of the fallen Utah service members. Its purpose is not just for the kids, it also brings together families who are in a similar situation. The camp aims to provide a recreational healing opportunity and creates general fun times for families who are grieving. Robert Pagnani explains, "We bring them here for three days and try to spoil them the best way that we can. We hope that we can take away the sadness, give them happiness, and show them how much we care about them." In July 2024, the Little Warriors Camp will be celebrating their 10th anniversary!!

At the start of the camp, the Utah Elks Veterans Program also provides backpacks filled with a camp shirt and fun surprises.

Over 56 Elks are involved from Utah Elks Lodges. The meals, gift items, and activity stations are provided by donations. For additional information contact Bob Pagnani, 435-830-1599.
